A RESOLUTION CONSIDERING THE PROTESTS,
APPROVING ASSESSMENT ENGINEER'S REPORT,
CONFIRMING THE ASSESSMENTS, AND ORDERING THE
IMPROVEMENTS, MAINTENANCE AND/OR SERVICES, IN
THE MATTER OF THE GREATER GOLDEN HILL
MAINTENANCE ASSESSMENT DISTRICT.

WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of "Greater Golden Hill Maintenance Assessment District," pursuant to Resolution No. R- 302731, adopted on JUN 12 2007, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The assessment ballots returned in favor of the levy of the assessment for the District are greater than those returned in opposition.
2. The Greater Golden Hill Maintenance Assessment District is ordered formed.
3. The assessments described in Document No. RR- 302731, on file in the office of the City Clerk and on file in the office of the Economic Development Division of Community and Economic Development Department, including the assessments against such parcels as are owned by public entities as described in Streets and Highways Code section 22663, are hereby confirmed and hereby constitute the levy of assessments.

4. The modified assessment district map for the "Greater Golden Hill Maintenance Assessment District," described in Document No. RR- 302887 is hereby confirmed and approved.

5. The improvements, maintenance and/or services described in said Resolution of Intention are hereby ordered performed.


6. The Engineer's Report for the Greater Golden Hill Maintenance Assessment District, and filed in the office of the City Clerk as Document No. RR- 302887, be and the same is hereby approved for these purposes.

7. The ballots returned in favor of the Greater Golden Hill Community Development Corporation administering the contracts for goods and services are represent a majority of the ownership of the area of the Greater Golden Hill Maintenance Assessment District.

8. The Mayor be and he is hereby authorized to negotiate a contract with the Greater Golden Hill Community Development Corporation pursuant to San Diego Municipal Code §§ 65.0212-65.0214.

BE IT FURTHER RESOLVED, that this activity is not a project and therefore exempt from CEQA pursuant to State Guidelines Section 15060(c)(3).
