A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING THE FISCAL YEAR 2008 BUDGET REPORTS FOR SPECIFIED BUSINESS IMPROVEMENT DISTRICTS, AND LEVYING ANNUAL ASSESSMENTS.
