Michael Aguirre, et al*, USDC Case No. 05 CV 1581; and *Erica Aaron, et al v. Michael Aguirre*, USDC Case No. 06 CV 1451.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend the amount not to exceed \$3,215,000 from the Public Liability Fund, solely, and exclusively for the purpose of providing funds for the above described legal services, contingent upon the City Auditor and Comptroller first furnishing one or more certificates demonstrating that the funds necessary for expenditures are, or will be, on deposit in the City Treasury.
