WHEREAS, Bob Kennedy worked as a land development consultant before serving as Volunteer Coordinator for the Harry Mathis for City Council Campaign in 1993, then went to work for Councilmember Mathis and eventually Councilmember Toni Atkins as a Council Representative until 2001; and

WHEREAS, beginning in June of 2001, Bob worked in the City of San Diego Community and Economic Development Department; and

WHEREAS, Bob worked for about four months in the Community and Economic

Development Department with the Business Expansion and Retention (BEAR) Team and was
then promoted to Project Manager for the City Heights Redevelopment Project, where he stayed
until his retirement; and

WHEREAS, during his tenure with the Redevelopment Agency, Bob has worked on all of the significant redevelopment projects in City Heights including the Urban Village Office and Townhomes, the Metro Center and Metro Villas, the Auburn Park housing project, the Talmadge Senior Village, the City Heights Square Project, the Euclid Tower Restoration Project, the Home in the Heights First Time Homebuyer Program, the City Heights housing rehabilitation program and the City Heights Project Area Committee; and

WHEREAS, Bob was a member of the Lake Murray Kiwanis Club from 1984 to 1988, serving as the organization's president from 1986 to 1988, has been a volunteer for the Southern California Regional Special Olympics since 1979, has been a committee member and volunteer for the Vietnam Veterans of San Diego "Stand Down" Event for the past eight years; and

WHEREAS, in 1997, Bob was the recipient of the Municipal Employees Associations'
