RESOLUTION AUTHORIZING PROCUREMENT OF CHEMICAL SUPPLIES AND SERVICES FROM U.S. PEROXIDE AND TAKING RELATED ACTIONS

BE IT RESOLVED, by the City of San Diego, as follows:

- 1. Bid Number 87-07-C for the procurement of chemical supplies and services for Peroxide Regenerated Iron-Sulfide Control from U.S. Peroxide (the U.S. Peroxide Procurement) for an initial period of one year, with the option to renew for four additional one year periods, is approved in an amount not-to-exceed \$1,934,500 for the first year provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer for the first year and for the option periods if the options are exercised.
- 2. That the expenditure of an amount not to exceed \$1,934,500 from Sewer Fund 41508, Dept. 771, is authorized solely and exclusively for the first year of the U.S. Peroxide Procurement, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.
- 3. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

That this activity is not subject to the California Environmental Quality Act 4. pursuant to CEQA Guidelines sections 15060 (c)(3) and 15378 (a) because this activity will not result in a direct or reasonably foreseeable indirect physical change in the environment.
