A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE SETTLEMENT AGREEMENT BETWEEN PAUL LOPEZ, ET AL. AND THE CITY OF SAN DIEGO IN THE AMOUNT OF EIGHTY-FIVE THOUSAND DOLLARS

To approve the mediated settlement agreement of each and every claim against the City of San Diego, its agents and employees, resulting from the personal injury and property damage claim of *Paul Lopez, et al. v. City of San Diego, et al.*.

BE IT RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to issue five checks in the sum total of \$85,000, in full settlement of this lawsuit and of all claims to be paid by issuing five checks as follows:

- 1. \$1,940.00 to Accent noted as "agent for Sante Health and Blue Shield for David Lopez"
- 2. \$2,560.00 to Paul and Estela Lopez for minor David Lopez
- 3. \$1,075.00 to Accent noted as "agent for Sante Health and Blue Shield for Alex Lopez"
- 4. \$2,425.00 to Paul and Estela Lopez for minor Alex Lopez
- 5. \$77,000.00 to Paul and Estela Lopez and attorney Francisco Sanchez, Jr.

BE IT FURTHER RESOLVED, that the City Council is hereby authorized to appropriately transfer funds of \$85,000 from the General Fund unallocated reserves to the Public Liability Fund 81140.
