A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING A GRANT APPLICATION AND RELATED ACTIONS FOR TRASH AND RECYCLING CONTAINERS AT SPECIAL EVENTS.

WHEREAS, Assembly Bill 2176 requires recycling at special events and large venues; and

WHEREAS, the California Department of Conservation – Division of Recycling has grant funds available for recycling and litter reduction; and

WHEREAS, such grant funding, if received by the City, would be used to provide trash and recycling containers at special events requiring a permit; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor or his designee is authorized to apply for and take all necessary actions to secure funding in the amount of \$122,297.62 from the California Department of Conservation Division of Recycling, to purchase trash and recycling containers for special events, as defined in San Diego Municipal Code section 22.4003, held within City limits.
- 2. That, subject to approval by the Mayor of final grant terms, the City Auditor and Comptroller is authorized to accept, appropriate, and expend grant award funds, and to establish a separate interest bearing account for such grant funds consistent with grant requirements.
- 3. That the Environmental Services Department Director is authorized to administer and operate the program when such grant funds are received.
