WHEREAS, in the 1940's, Eleanor drove with her mother to Coronado, California to join her father who found work with Consolidated Vultee Aircraft Corporation, later known as Convair and General Dynamics; and

WHEREAS, Eleanor attended Coronado Elementary School during the war years and grew to love the sounds and smells of the Silver Strand, the beaches and bay. She used to ride the ferry back and forth from Coronado to San Diego all day for a nickel; and

WHEREAS, in 1944 Eleanor moved to a new development for defense workers in La Jolla and attended La Jolla Elementary, Junior and High Schools. Eleanor was a "Beach Rat" who loved to explore the beaches at the Children's Pool and enjoyed swimming to the fishing boats from the Cove; and

WHEREAS, Eleanor and her husband purchased a home in Clairemont's Mountain area in 1959, where they live to this day. She raised five children who attended Riley Elementary, Hale Junior High and Madison High School; and

WHEREAS, Eleanor attended Mesa College and studied Early Childhood Education. She then proceeded to San Diego State University and earned a Bachelor of Science degree in Management, with honors; and

WHEREAS, in 1978, Eleanor took a job with an ink manufacturing firm in Escondido where she started as an Administrative Assistant and left as the Vice President of Operations. Her career took her abroad to many wonderful cities but none compared to beautiful San Diego; and


WHEREAS, in 1998, Eleanor retired to pursue exciting volunteer positions in education, community, and politics; and


