## RESOLUTION TO APPROVE FUNDS FOR HICKMAN ATHLETIC FIELD IMPROVEMENTS

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That in accordance with the 2008 Annual Appropriation Ordinance, the City Auditor and Comptroller is authorized and directed to amend the Capital Improvement Budget to add CIP No. 29-795.0, Hickman Athletic Field Improvements.
- 2. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$200,000 from Fund 39223, General Dynamic Fund to CIP No. 29-795.0, Hickman Athletic Field Improvements.
- 3. That the expenditure of an amount not to exceed \$200,000 from CIP No. 29-795.0, Hickman Athletic Field Improvements, is authorized, solely and exclusively for the purpose of providing funds for consultant services to prepare construction documents for Hickman Athletic Field.
- 4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
- 5. That this activity is not a "project" and therefore not subject to CEQA per CEQA Guidelines Section 15060 (c) (3). This activity will provide funding for a project consultant, design, and construction documents. There is no construction associated with this action. Any

future activity involving construction will be subject to a separate review under CEQA and conditioned to comply with the provisions of CEQA.
