WHEREAS, The Center on Policy Initiatives [CPI] was founded in 1997 as an independent, nonprofit research and advocacy organization whose goal was to advance policies that help San Diego's workers; and

WHEREAS, CPI has combined high-quality research with policy advocacy and community organizing to achieve results in a relatively politically conservative city; and

WHEREAS, CPI seeks a fair economy in San Diego with good jobs and health care coverage that allows working people dignity and hope for the future; and

WHEREAS, through coalition building, public education, media outreach and leadership development, CPI strives to counter the growing inequality in power and income facing San Diego and the country as a whole; and

WHEREAS, CPI has released original and insightful studies on a wide range of issues such as inclusionary housing policy, San Diego service and revenue levels, and the growth of working poverty in our city; and

WHEREAS, CPI led the way on the Living Wage Ordinance, which requires companies with city contracts to pay workers \$10 per hour plus healthcare coverage or \$12 an hour without benefits; and

WHEREAS, CPI recently released a comprehensive study on the state of health care coverage in California, which reported that less than one half of California workers receive health care through their employers; and

track campaign contributions made to local candidates; and

WHEREAS, CPI's development watch program enables community members to keep an

eye on large-scale development projects and their possible effects on the nearby neighborhoods;

WHEREAS, CPI gives low to moderate income communities the chance to stay involved

and informed in the decisions affecting their neighborhoods; NOW, THEREFORE,

10 years of successful research and advocacy in the San Diego community.
