- 1. That the Fiscal Year 2008 Capital Improvements Program Budget for CIP No. 39-207.0, North Park Main Street/University Avenue Streetscape Improvements [Project], Fund No. 79502, North Park Developer Impact Fees, is amended by increasing the budget amount by \$250,000.
- 2. That the appropriation and expenditure of an amount not to exceed \$250,000 from CIP No. 39-207.0, North Park Main Street/University Avenue Streetscape Improvements, Fund No. 79502, North Park Development Impact Fees, is authorized solely and exclusively for the purpose of providing funds for the Project, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.
- 3. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301, existing facilities.
