A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT GRANT OF EASEMENT DOCUMENT GRANTING A DRAINAGE EASEMENT ACROSS PORTIONS OF LOTS 28 AND 29 OF FLEISHER'S ADDITION TO SAN DIEGO.

WHEREAS, the City of San Diego agreed to construct new drainage facilities at and adjacent to the 6th Avenue cul de sac; and

BE IT RESOLVED, be it resolved by the Council of the City of San Diego, that the Mayor is authorized to accept Grant of Easement Document by Windmill Construction Company/Promontory Pont LLC, granting a drainage easement across portions of Lots 28 and 29 of Fleisher's Addition to San Diego, according to Map thereof, No. 811, filed in the Office of the County Record.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is authorized to disburse Two Thousand Five Hundred Dollars (\$2,500), from CIP 130050 (JO130082), 6th Avenue Drain Replacement, for acquisition of the property rights required for completion of the project.
