A RESOLUTION AUTHORIZING EXPENDITURE FOR  
COMMERCIAL VEHICLE PROHIBITION ON RIVIERA  
DRIVE.

WHEREAS, Section 85.04 of the City of San Diego Municipal Code authorizes the City Council, by resolution, to prohibit large commercial vehicles from using any street or portion thereof; and

WHEREAS, the residents of the portion of Riviera Drive between Pacific Beach Drive and Ingraham Street support the establishment of such prohibition; and


WHEREAS, the Mayor has reviewed this petition and determined that this prohibition can be implemented without compromising traffic circulation or safety, NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor be and is hereby authorized and empowered to establish a prohibition of commercial vehicles with a rated capacity of five tons or more on Riviera Drive between Pacific Beach Drive and Ingraham Street.

BE IT FURTHER RESOLVED, that the expenditure of \$900 from Fund 100, is authorized solely and exclusively for this Project, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that this activity is exempt from California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060(c)(2).


