WHEREAS, since its founding, the Fraternal Order of Eagles has raised over 100 million dollars for local and national charities; and

WHEREAS, it is estimated that all donations from the Fraternal Order of Eagles to communities, charities and social programs will exceed \$10,000,000 a year; and

WHEREAS, the members of the Fraternal Order of Eagles are united to preserve liberty, insist on truth, demand justice and promote equality; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby congratulate and commend the Fraternal Order of Eagles for success over the past 105 years and its service to the San Diego community.

BE IT FURTHER RESOLVED, that September 7, 2007 be and is hereby proclaimed to be, "FRATERNAL ORDER OF EAGLES DAY" in the City of San Diego.
