A RESOLUTION ACCEPTING GRANT FUNDING FROM THE INDIAN GAMING LOCAL COMMUNITY BENEFIT COMMITTEE IN THE AMOUNT OF \$535,498 AND AUTHORIZING THE APPROPRIATION OF SAME FOR THE PROCUREMENT OF DIGITAL DOWNLOAD MICROWAVE EQUIPMENT.

WHEREAS, the Indian Gaming Local Community Benefit Committee [IGLCBC] grants monies to local entities and agencies impacted by tribal gaming; and

WHEREAS, the City, through its Fire-Rescue Department and Corporate Partnership Program [CPP], has previously submitted and been awarded grant funds for equipment and operational needs from the IGLCBC; and

WHEREAS, the City, through its Fire-Rescue Department and CPP submitted a 2004 grant proposal and was awarded the amount of \$320,417 to help fund operations of the Regional Fire and Rescue Helicopter Program and staffing costs; and

WHEREAS, the City, through its Fire-Rescue Department and CCP submitted a 2005 grant proposal and was awarded the amount of \$250,000 for the purchase of a fuel service vehicle and fuel for the Regional Fire and Rescue Helicopter Program; and

WHEREAS, the City, through its Fire-Rescue Department and CCP submitted 2006 grant proposals and was awarded \$175,000 to be used towards the purchase of a Portable Live Fire Training Unit, and \$170,000 for the procurement of digital microwave downlink equipment; and

WHEREAS, the City, through its Fire-Rescue Department and CCP, submitted 2007 grant proposals to IGLCBC and was granted \$535,498 for the procurement of digital microwave


downlink equipment to implement Phase 3 of the Regional Command and Control Communications (3C's) project; and

WHEREAS, the equipment purchased to implement Phase 3 of the 3C's project will utilize new technology to better improve response from fire-rescue and law enforcement agencies through better situational awareness and improved communications from incident command posts in the field; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to accept \$535,498 of funding from the IGLCBC to be deposited into Fund 10264, for the procurement of digital download microwave equipment to implement Phase 3 of the Regional Command and Control Communications Project for the Fire-Rescue Department.

BE IT FURTHER RESOLVED that the Auditor and Comptroller is authorized to appropriate and expend grant funds from Fund 10264, for the procurement of digital download microwave equipment for the Fire-Rescue Department's Air Operations Division.


