WHEREAS, on July 15, 2007, Navajo Canyon Republican Women Federated [NCRWF] celebrated its forty-fifth anniversary, and it is appropriate to highlight its many achievements and underscore the positive impact it has made in the local community; and

WHEREAS, NCRWF is affiliated with the National Federation of Republican Women [NFRW], which was founded in 1938 and is one of the largest and most influential women's grassroots political organizations in the country; and

WHEREAS, NCRWF was awarded the NFRW's highest honor, the Diamond Club Achievement Award, at the National Federation of Republican Women bi-annual convention in September, 2007; and

WHEREAS, NCRWF joins with the National Federation in its mission to strengthen the Republican Party by electing candidates, advocating the Party's philosophy and initiatives, and educating and empowering women of all ages, ethnicities and backgrounds in the political process; and

WHEREAS, NCRWF was chartered on June 7, 1962, as the College Gardens Republican Women, Federated, then changed its name to Navajo Republican Women as the Navajo area was developed and changed to its current name in 2006 to reflect the beauty of the community's natural open spaces; and

WHEREAS, since its inception more than four decades ago, the members of NCRWF have contributed extensively to the people of San Diego through their support of one of our nation's more precious rights – participation in the political system; and

WHEREAS, many NCRWF members have been elected to serve in local or state-wide office; and

WHEREAS, today, NCRWF is comprised of more than 130 members who have contributed thousands of hours to registering voters and supporting Republican nominees; and

WHEREAS, NCRWF programs include discussions of political topics and issues of local, state and national interest; and

WHEREAS, in addition to supporting Republican principles and candidates, members of NCRWF are active in community causes, both as a club and as individuals, which promote literacy, award scholarships, support the men and women of the United States Armed Forces and their families, as well as local women and families in need; and

WHEREAS, the achievements and advancements which the members of Navajo Canyon Republican Women Federated have made through their efforts have been of great value to the people of San Diego and reflect their devotion to the highest ideals of volunteer service; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, recognizes and salutes the members of
