WHEREAS, San Diego Municipal Code section 125.1010(c) et seq. provides for the summary abandonment easements by City Council resolution where the easements to be vacated have not been used for the purpose for which they were dedicated or acquired for five consecutive years prior to the proposed vacation and there are no other public facilities located within the easements; and

WHEREAS, the affected property owners have requested the vacation of the unnecessary sewer, water, drainage and public utility easements in Lot 6 of City of San Diego Industrial Park Unit No. 1, Map No. 3978 and in Lot 8 of City of San Diego Industrial Park Unit No. 2, Map No. 4113 as depicted on Engineering Drawing No. 20685-B, to unencumber their property; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the sewer, water, drainage and public utility easements, either for the purpose for which they were originally acquired, or for any other public use of a like nature that can be anticipated; and
- (b) the public will benefit from the vacation through improved utilization of land made available by the abandonment; and
  - (c) the vacation is consistent with the General Plan or an approved Community Plan; and
- (d) the public facility or purpose for which the easements were originally acquired will not be detrimentally affected by this vacation; and

WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body and where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the sewer, water, drainage and public utility easements located within Lot 6 of City of San Diego Industrial Park, Unit No. 1, Map No. 3978 and in Lot 8 of City of San Diego Industrial Park, Unit No. 2, Map No. 4113, as more particularly described in the legal description marked as Exhibit "A," and shown on Drawing No. 20685-B, marked as Exhibit "B," and on file in the office of the City Clerk as Document Nos. RR- 303187-, and RR-303187-, and RR-303187-, and RR-303187-.

2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by her under seal, to be recorded in the office of the County Recorder.
