DATE OF FINAL PASSAGE DEC - 3 2007

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING APPOINTMENTS TO THE  
STANDING COMMITTEES FOR CALENDAR YEAR 2008.

WHEREAS, San Diego Charter section 270(d) provides that the City Council shall have the right to determine its own rules and order of business; and

WHEREAS, Rule 6.1 of the Permanent Rules of the City Council, San Diego Municipal Code section 22.0101.5, provides that there shall be five standing committees of the City Council; and

WHEREAS, Rule 6.2.1 provides that for each committee, except for the Committee on Rules, Open Government, and Intergovernmental Relations [Rules Committee], the Council President shall, no later than the second meeting of the Council in January of each year, nominate the committee Chair, vice-chair, and committee members, subject to confirmation by a majority vote of the City Council; and

WHEREAS, the Council has adopted temporary Rule 6.11.1, that states that the Council President Pro Tem shall serve as the Chair of the Rules Committee and that the Council President shall serve as the Vice-Chair; and

WHEREAS, the Council has adopted temporary Rule 6.11.7 to create an Ad Hoc Committee on Fire Prevention and Recovery, to be in effect for one year; and

WHEREAS, on November 13, 2007, the City Council adopted Resolution No. R-303172, selecting Councilmember Scott Peters as Council President for a third term commencing on January 1, 2008; and

WHEREAS, the Council President-elect has submitted nominations for each committee Chair, vice-chair, and committee members, for a term commencing on January 1, 2008; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to section 22.0101.5 of the Municipal Code of the City of San Diego, the following appointments by the Council President-elect to serve as Chairs, vice-chairs, and committee members of the five standing Council committees for terms commencing January 1, 2008, and lasting until December 8, 2008, be and the same are hereby confirmed:
