A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO
AUTHORIZING THE SETTLEMENT AGREEMENT BETWEEN
JOSE ANTERO BAUTISTA AND THE CITY OF SAN DIEGO IN
THE AMOUNT OF SIXTY THOUSAND DOLLARS


WHEREAS, in Closed Session on July 31, 2007, by motion of Councilmember Madaffer and seconded by Councilmember Atkins, the City Council, by the following Vote: Yeas, 5; Nays, None; Not Present, Councilmembers Maienschein and Hueso, approved the following motion:

To approve the settlement agreement of each and every claim against the City of San Diego, its agents and employees, resulting from the personal injury claim *Jose Antero Bautista et al v. City of San Diego*.

BE IT RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to issue checks totaling the sum of \$60,000 made payable to Jose Antero Bautista and the Law Offices of Bricton & Cohen and various payees, in full settlement of the lawsuit and of all claims.

BE IT FURTHER RESOLVED, that the City Council is hereby authorized to pay the sum of \$60,000 from the Public Liability Fund 81140.
