AN ORDINANCE OF THE CITY OF SAN DIEGO AUTHORIZING A SIX-YEAR MEMORANDUM OF UNDERSTANDING WITH THE COUNTY OF SAN DIEGO AND OTHER PUBLIC AGENCIES TO SHARE THE COSTS OF REGIONAL WATER QUALITY CONTROL BOARD ORDER NO. R9-2007-0001 REGARDING THE PREVENTION OF STORM WATER POLLUTION.

WHEREAS, the Regional Water Quality Control Board, San Diego Region, issued Order No. R9-2007-0001 in connection with discharges to the storm water conveyance system; and

WHEREAS, Order No. R9-2007-0001 is regional in its scope and applies to all municipal entities in the region and to the County of San Diego who own and operate municipal separate storm sewer systems; and

WHEREAS, Order No. R9-2007-0001 refers to the regulated parties as Copermittees and to the County as Principal Permittee; and

WHEREAS, Order No. R9-2007-0001 mandates that the Copermittees cooperate with respect to specified regional and watershed storm water pollution prevention activities; and

WHEREAS, the Copermittees have previously coordinated regional storm water pollution prevention activities under prior Order No. R9-2001-01 pursuant to a Memorandum of Understanding providing for the sharing of responsibilities and costs; and

WHEREAS, under a new Memorandum of Understanding between the Copermittees for Order No. R9-2007-001, the City would share costs of storm water compliance with the County of San Diego, San Diego Unified Port District, Regional Airport Authority, and the cities of Carlsbad, Chula Vista, Coronado, Escondido, Imperial Beach, La Mesa, San Marcos, Del Mar,

El Cajon, Encinitas, Lemon Grove, National City, Oceanside, Poway, Santee, Solana Beach, and Vista; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a six-year Memorandum of Understanding with the County of San Diego, as Principal Copermittee, and other public agencies as Copermittees, to share costs for activities necessary to comply with requirements of Regional Water Quality Control Board Order No. R9-2007-0001, under the terms and conditions set forth in the Memorandum of Understanding, on file in the office of the City Clerk as Document No. OO-

Section 2. That the expenditure of an amount not to exceed \$791,936.00 is authorized, solely and exclusively to provide funds for the first year of the City's share of the above program costs, to be expended as follows: \$375,084.40 from Fund No. 100, Dept 533, Org 2250; and \$416,851.60 from Fund No. 10508, Dept 10508, Org 2250.

Section 3. That this activity is not a "project" and is therefore exempt from the California Environmental Quality Act pursuant to CEQA Guidelines section 15060(c)(3).

Section 4. That a full reading of this ordinance is dispensed with prior to passage, since a written copy was made available to the City Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
