ORDINANCE NUMBER O- 19703 (NEW SERIES)

AN ORDINANCE AMENDING ORDINANCE NO. O-19652 (NEW SERIES) ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 2008 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY ADDING A COMMITTEE CONSULTANT POSITION AND TRANSFERRING \$40,000 FROM THE FY 2008 APPROPRIATED RESERVE TO FUND THE POSITION.

WHEREAS, on July 30, 2007, the City Council adopted Ordinance No. O-19652 [Appropriation Ordinance]; and

WHEREAS, an amendment to the Appropriation Ordinance is necessary to add a

Committee Consultant position to staff the Ad Hoc Committee on Fire Prevention and Recovery

and transfer funds to Council Administration to fund the position; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Auditor and Controller is authorized to add 1.0 position to the Council Administration (Dept. 029) and to transfer, appropriate, and expend \$40,000 from the FY 2008 appropriated reserve to the Council Administration (Dept. 029) for a Committee Consultant position to staff the Ad Hoc Committee on Fire Prevention and Recovery.

Section 2. That Ordinance No. O-19652 (New Series) entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 2008 and Appropriating the Necessary Money to Operate the City of San Diego for Said Fiscal Year" be and the same is hereby amended by increasing the Council Administration (Dept. 029) by 1.0 position and \$40,000 for salary and fringe for the balance of FY 2008.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public prior to the day of its passage.

Section 4. This ordinance is declared to take effect and be in force immediately upon its final passage after two public hearings pursuant to the authority contained in sections 71, 275 and 295 of the Charter of the City of San Diego.
