A RESOLUTION OF THE SAN DIEGO CITY COUNCIL AUTHORIZING THE MAYOR TO EXECUTE CONTRACT AMENDMENT NO. 3 WITH HNTB CORPORATION FOR DESIGN SERVICES AND CONSTRUCTION SUPPORT FOR THE BROWN FIELD AIRPORT ELECTRICAL SYSTEM UPGRADES, PHASES II AND III, CIP NO. 31-300.0; AUTHORIZE THE AUDITOR AND COMPTROLLER TO EXPEND UP TO \$138,279 FROM CIP NO. 31-300.0 FOR THE PURPOSES SET FORTH IN AMENDMENT NO. 3; AUTHORIZE THE AUDITOR AND COMPTROLLER TO TRANSFER EXCESS FUNDS IN THE AMOUNT OF \$1,361,721 FROM CIP NO. 31-300.0, BROWN FIELD ELECTRICAL SYSTEM UPGRADES, PHASE 1, TO CIP NO. 31-001.1, BROWN FIELD ANNUAL ALLOCATION.

WHEREAS, the City Airports Division continues its project to improve the runway lighting system at Brown Field Airport with a general upgrade, to be designed in accordance with Federal and State standards for airports, estimated to cost 4.5 million dollars, to increase safety and operation efficiency at Brown Field Airport; and

WHEREAS, the Federal Aviation Administration [FAA] designated this project as a high priority and provided \$1,111,500 for Phase 1 of the work; and

WHEREAS, it is anticipated that in the near future the FAA will provide additional funds to continue the improvements to be done in Phases 2 and 3; and

WHEREAS, the electrical upgrade is designed to correct the wet weather generalized failures of the system and associated repair bills; and

WHEREAS, Phases 2 and 3 of the project require additional design and construction support services; and

WHEREAS, HNTB Corporation is the consultant who provided design services, satisfactory to the Airport Engineer, on Phase 1 of this project and continuity in the plans and specifications is, in the opinion of the Airport Engineer, necessary and prudent in a project of this importance and scope; and

WHEREAS, during the 2008 budget preparation for the Airports Division the sum of \$1,500,000 was erroneously appropriated to CIP 31-300.0, Brown Field Electrical Upgrades, instead of CIP 31-001.1, Brown Field Annual Allocation, and said funds are needed by the Airports Division for Brown Field; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor, or his designee, is authorized to execute Amendment No. 3 to the agreement between the City of San Diego and HNTB Corporation for Airfield Electrical Design of Brown Field Airport, a copy of which is filed in the office of the City Clerk as Document No. (R-303293 (Amendment No. 3), for additional design services for Phases 2 and 3 of the Brown Field Electrical System Upgrade, CIP No. 31-300.0 in an amount not to exceed
- 2. BE IT FURTHER RESOLVED THAT the Auditor and Comptroller is authorized to expend up to \$138,279 from CIP No. 31-300.0 for any of the purposes set forth in Contract Amendment No. 3; and
- 3. BE IT FURTHER RESOLVED THAT the Auditor and Comptroller is authorized to transfer \$1,361,721 from CIP No. 31-300.0, Brown Field Electrical System Upgrade Phase 1, to CIP No. 31-001.1, Brown Field Annual Allocation;
