A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT WITH HARRIS & ASSOCIATES FOR THE LA JOLLA ECOLOGICAL RESERVE AREA OF SPECIAL BIOLOGICAL SIGNIFICANCE (ASBS 29) IN THE LA JOLLA COMMUNITY PLANNING AREA.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor be and he is hereby authorized and empowered to execute, for and on behalf of the City of San Diego [City], an agreement with Harris & Associates for the purpose of design professional services for the La Jolla Ecological Reserve Area Special Biological Significance (ASBS 29) [Project] under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR ~ 303322 [Agreement].
- 2. That the expenditure of an amount not to exceed \$399,182 from Fund No. 630221, Contributions from 100 Fund, CIP No. 12-160.0, La Jolla Ecological Reserve Area of Special Biological Significance (ASBS 29) (WO#121600), is authorized for the purpose of executing the Agreement for the above referenced Project.
- 3. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this project is exempt from CEQA pursuant to State CEQA Guidelines Section 15060(c)(2).
