- Support for eliminating the sunset provision for the San Diego River
 Conservancy;
- 6. Direction that the City ensure more communication and participation with the community involved or impacted when the City applies for grants, and provide information on the monitoring requirements costs for the grant money; and
- 7. Direction to staff to provide analysis on changing the law for the Border Development Zone.
