A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REQUESTING THE CONSOLIDATION OF A MUNICIPAL PRIMARY ELECTION TO BE HELD IN THE CITY OF SAN DIEGO ON JUNE 3, 2008 WITH THE STATEWIDE PRIMARY ELECTION TO BE HELD ON THE SAME DATE.

WHEREAS, Section 10 of the Charter of the City of San Diego provides that commencing with the year 1998 the Municipal Primary Elections to the offices of Mayor, City Attorney, and Councilmember of Districts 1, 3, 5, and 7 shall be held on the same date in each election year as the California State Primary Election, and the General Municipal Election for these offices shall be held on the same date as the California State General Election for that year; and

WHEREAS, in the year 2008, the Statewide Primary Election will be held on the 3rd day of June;

WHEREAS, at a meeting on <u>FEB 0 4 2008</u>, the City Council passed Ordinance No. O- <u>13712</u>(N.S.), calling a Municipal Primary Election in the City of San Diego on Tuesday, June 3, 2008; and

WHEREAS, calling the Municipal Primary Election for the same date as the Statewide Primary Election is mandated by Section 10 of the Charter of the City of San Diego and, therefore, is not subject to veto by the Mayor; and

WHEREAS, it is desirable that this Municipal Primary Election be consolidated with the Statewide Primary Election to be held on the same date and that within the City of San Diego the

election precincts, polling places, voting booths, and election officials for the two elections be the same; and

WHEREAS, it is desirable that the Board of Supervisors of the County of San Diego be authorized to canvass the returns of the Municipal Primary Election; and

WHEREAS, it is desirable that this election and the Statewide Primary Election be held in all respects as if there were only one election; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. The Board of Supervisors of the County of San Diego is hereby requested to consolidate the Municipal Primary Election for the offices of Mayor, City Attorney, and Councilmember for Districts 1, 3, 5, and 7 to be held in the City of San Diego on June 3, 2008, with the Statewide Primary Election to be held on the same date.
- 2. That the Board of Supervisors of the County of San Diego is hereby authorized to canvass the returns of the Municipal Primary Election and is requested to conduct the election in all respects as if there were only one election using only one form of ballot.
- 3. That the Board of Supervisors of the County of San Diego is requested to issue to all officers of the County charged with duties pertaining to the Statewide Primary Election appropriate instructions to take any and all steps necessary for the holding of a consolidated election.
- 4. That the Board of Supervisors of the County of San Diego is hereby requested to authorize and direct the Registrar of Voters of the County of San Diego to perform the following:
 - (a) Furnish a tabulation of the number of registered voters in each Council district by precinct;
 - **(b)** Examine and verify the signatures on nominating petitions;

- (c) Provide minority language election materials in accordance with federal law;
- Canvass the returns of the election, including absent voter ballots;
- Furnish a tabulation of the number of votes given in each precinct; and
- (f) Furnish a tabulation of the number of votes given in each Council district by precinct.
- (g) Complete any and all tasks related to the legal conduct of this election as required of the City Clerk upon the request of the City Clerk or the City Council.
- 5. That the City Clerk of the City of San Diego is hereby directed to file a certified copy of this Resolution with the Board of Supervisors and Registrar of Voters of the County of San Diego.

BE IT FURTHER RESOLVED, that the City Auditor and Controller is authorized to reimburse the County of San Diego for the actual and direct cost of the services performed by the Registrar of Voters for the City of San Diego in connection with the election services herein described, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City of San Diego agrees to indemnify and to save free and harmless the County, its officers, agents, and employees from expense or liability,
