WHEREAS, Jennifer Jones researched and wrote foundation proposals for grants as large as \$200,000, produced more than 50 annual fundraising events and produced the most financially successful AIDS Walk San Diego benefiting HIV/AIDS service providers for The Center; and

WHEREAS, prior to her service as Director of Development at The Center, Jennifer Jones served in resource development positions at the DC Appleseed Center for Law and Justice, the Victory Fund, and the Human Rights Campaign in Washington, D.C., creating many new programs and opportunities for financial support for these two community-based organizations; and

WHEREAS, Jennifer Jones has also had a distinguished career providing consulting services in public affairs, communications, and direct marketing to major nonprofit organizations, including the California Teachers Association, San Diego Municipal Employees Association, The Sierra Club, the Democratic National Committee and Planned Parenthood; and

WHEREAS, Jennifer Jones has accepted the position of Vice-President for Client Services for O'Brien, McConnell & Pearson, an esteemed political fundraising and

communications consulting firm in Washington, D.C., whose clients include Amnesty International, Senator Hillary Clinton, and the Democratic Congressional Campaign Committee; and


WHEREAS, Jennifer Jones will step down from her position at the LGBT Center on January 15, 2008; NOW, THEREFORE,
