A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING
A THIRD AMENDMENT TO THE AGREEMENT BETWEEN
THE CITY AND IMS RECYCLING SERVICES AND ALLAN
COMPANY FOR PROCESSING, TRANSPORTING, AND
MARKETING CURBSIDE RECYCLABLES.

WHEREAS, the Environmental Services Department requires the continued services of a contractor to process, transport, and market the material collected in the City's curbside recycling program; and

WHEREAS, in 1998, after completion of a competitive request for proposal process, the Council authorized the execution of an agreement with IMS Recycling Services and Allan Company for such services, which agreement is on file in the Office of the City Clerk as document number RR-290886; and

WHEREAS, pursuant to the agreement, the Council authorized two subsequent amendments to the agreement; and

WHEREAS, a third amendment will allow these companies to continue providing such services in support of the City's efforts to meet the state-mandated waste diversion goals; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his duly authorized representative is authorized and empowered to execute, for and on behalf of the City, a third amendment to the agreement with IMS Recycling Services and Allan Company for processing, transporting, and marketing commingled curbside recyclables, under terms and conditions set forth in the Third Amendment, on file in the office of the City Clerk as Document




