A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING A MEMORANDUM OF UNDERSTANDING WITH REHRIG PACIFIC COMPANY FOR AUTOMATED REFUSE COLLECTION CONTAINERS ON AN AS-NEEDED BASIS.

WHEREAS, the City's refuse collection policy requires that containers for refuse, recycling, and greenery be provided by the City to customers; and

WHEREAS, the estimated requirement for these containers is 17,000 in 2008; and WHEREAS, the City is in need of an agreement for furnishing of these containers to the City as needed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement with Rehrig Pacific Company to furnish automated refuse, recycling, and greenery containers to the City on an as-needed basis for the term June 26, 2007 through November 30, 2011, and under terms and conditions set forth in the Memorandum of Understanding, on file in the office of the City Clerk as Document No. RR-303445.
- 2. That the expenditure of an amount not to exceed the amount budgeted per fiscal year from General Funds No. 100 and 10509 (refuse containers) and Recycling Fund No. 41210 (recycling and greenery containers) is authorized, to provide funds for the above Memorandum of Understanding, provided that the City Auditor and Comptroller furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit

with the City Treasurer. It is estimated that approximately \$800,000 will be expended in Fiscal Year 2008.

3. That the above activity is not a project pursuant to CEQA Guidelines section 15378(b)(2) because this activity constitutes ongoing administrative or maintenance activities, and therefore is not subject to the California Environmental Quality Act pursuant to CEQA Guidelines section 15060(c)(3).
