BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is hereby authorized and empowered to pay the amount of \$530,000.00 in the settlement of each and every claim of Vadnais Corporation against the City, its agents and employees, arising from the Sewer Pump Station 30A - Alternative Project as set forth in San Diego Superior Court Case No. GIC 854791, Vadnais Corp. et al. v City of San Diego.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to appropriate and issue two checks, one in the amount of \$376,544.48 and one in the amount of \$153,455.52 (total of \$530,000.00), payable to Vadnais Corporation in full settlement of all claims arising from the Sewer Pump Station 30A - Alternative Project.

BE IT FURTHER RESOLVED, that \$376,544.48 is to be payable from Sewer Fund No. 41506, and \$153,455.52 is payable from Sewer Pump Station 30A Project Fund CIP 46-200.0
