WHEREAS, in the Closed Session Meeting of February 26, 2008, in the matter of Sean Brennan v. City of San Diego (San Diego Superior Court Case No. GIC 880969), the City Council voted 8 to 0 to approve the settlement. The motion was made by Councilmember Atkins with a second by Councilmember Frye.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of San Diego that the Council authorizes:

- 1. The sum of \$160,000.00 to be paid from the Public Liability Fund (81140) in settlement of each and every claim against the City, its agents and employees, arising from the Litigation.
- 2. The City Auditor and Comptroller to issue a check in the amount of \$160,000.00 payable to Thorsnes Bartolotta McGuire Client Trust Account re: Sean Brennan.
