BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, an amendment to the agreement with Goodwin Simon Victoria Research for professional services in Fiscal Years 2008-2009 regarding the City's Think Blue Program, under the terms and conditions set forth in the First Amendment, on file in the office of the City Clerk as Document No. RR- 303538.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$446,470 from General Fund No. 100, General Services, Storm Water Pollution Prevention Division, Dept. 533, is authorized, solely and exclusively to provide funds for the above First Amendment.

BE IT FURTHER RESOLVED, that this activity is not a project and therefore is not subject to the California Environmental Quality Act pursuant to CEQA Guidelines section 15060(c)(3).


