A RESOLUTION APPROVING AND RATIFYING FISCAL YEAR 2009 MEMORANDUM OF UNDERSTANDING AS A TERM SHEET FOR THE POLICE OFFICER'S ASSOCIATION [POA] AND AUTHORIZING THE MAYOR, IN CONJUNCTION WITH THE CITY ATTORNEY, TO INITIATE LITIGATION.

WHEREAS, the Management Team of the City of San Diego has met and conferred with the Police Officer's Association [POA]; and

WHEREAS, the Management Team of the City of San Diego reached an agreement with the POA on an FY 2009 Memorandum of Understanding regarding wages, hours, and other terms and conditions of employment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to these negotiations, the Management Team and POA have agreed to the provisions contained in the respective Memorandum of Understanding as a term sheet subject to the final Memorandum of Understanding returning to the City Council on May 20, 2008 for ratification, a copy of which is on file in the office of the City Clerk as Document Number: RR- 303562.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, the Mayor is authorized, in cooperation with the City Attorney, to initiate litigation, as soon as practicable, consistent with the language in Article 44 Section 12 of the FY 2009 POA Memorandum of Understanding to determine the vested status of DROP and Purchase of Service Credits as follows:

1. Is the Deferred Retirement Option Plan [DROP] and/or any and all MOU/Code provisions allowing for the purchase of service credit for retirement benefit calculation purposes, "vested" benefits;

2. Can the purchased service credits be utilized to determine vesting into the retirement system;
3. Are these benefits subject to modification pursuant to any and all provisions of the City Charter or other applicable rules and regulations;
4. And/or what, if any, conditions precedent exist to the implementation of City-initiated steps by which to modify and/or eliminate DROP and/or service credits.




