- 2. That the Fiscal Year 2008 Capital Improvements Program Budget for CIP No. 29-938.0, Canyonside Community Park Sports Field Lighting Upgrades, is amended by increasing the budget amount by \$345,000; \$205,000 in Fund No. 39085, Penasquitos East Park Development Fund and \$140,000 in Fund No. 392190, Black Mountain Ranch Development Agreement.

- 4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the Penasquitos Linear Park off-leash dog area Project.
