A RESOLUTION AUTHORIZING THE CITY ATTORNEY TO ENTER INTO AN AGREEMENT WITH BROWN LAW GROUP IN AN AMOUNT UP TO \$150,000 TO PROVIDE LEGAL SERVICES IN CONNECTION WITH THE DEFENSE OF JACQUELINE LINDSAY V. OFFICE OF THE CITY ATTORNEY, CITY OF SAN DIEGO; KAREN HEUMANN, ET AL., AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO EXPEND RELATED FUNDS

WHEREAS, In November 2007, Jacqueline Lindsay filed a complaint against the City and an Assistant City Attorney, San Diego Superior Court Case No. 37-2007-00081422-CU-WT-CTL, and due to the conflict of interest outside counsel is recommended; and

WHEREAS, the firm of Brown Law Group has the necessary skills and experience to assist the City in defense of this matter; and

WHEREAS, the Council of the City of San Diego has been briefed on the status of this matter in a duly-noticed Closed Session meeting on February 25, 2008; and

WHEREAS, the Council determined to retain Brown Law Group to assist the City in defense of this matter; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney is authorized to retain Brown Law Group for the provision of legal services in *Jacqueline Lindsay* v. Office Of The City Attorney, City Of San Diego; Karen Heumann, et al., San Diego Superior Court Case No. 37-2007-00081422-CU-WT-CTL, in an amount not to exceed \$150,000.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is authorized to expend up to \$150,000 from the Public Liability Fund.
