A RESOLUTION AUTHORIZING THE CITY ATTORNEY TO CONTINUE THE RETENTION OF BROWN LAW GROUP IN AN AMOUNT UP TO \$250,000 TO PROVIDE LEGAL SERVICES IN CONNECTION WITH THE DEFENSE OF BEVIER AND HOLLINGSWORTH V. CITY ATTORNEY MICHAEL J. AGUIRRE, AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO EXPEND RELATED FUNDS

WHEREAS, In May 2007, Council authorized the retention of Brown Law Group to defend the action against the City of San Diego in *Bevier and Hollingsworth v. City Attorney Michael J. Aguirre*, San Diego Superior Court Case No. GIC787380; and

WHEREAS, the firm of Brown Law Group has the necessary skills and experience to assist the City in defense of this matter; and

WHEREAS, the Council of the City of San Diego has been briefed on the status of this matter in a duly-noticed Closed Session meeting on February 25, 2008; and


WHEREAS, the Council determined to continue the retention of Brown Law Group to assist the City in defense of this matter; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney is authorized to continue the retention of Brown Law Group for the provision of legal services in *Bevier and Hollingsworth v. City Attorney Michael J. Aguirre*, San Diego Superior Court Case No. GIC787380, in an amount not to exceed \$250,000.
