City of San Diego, et al., Case No. 37-2007-00067110-CU-PA-CTL [the Litigation]; and

WHEREAS, in the Closed Session Meeting of February 26, 2008, in the matter of James Christian Cooper v. City of San Diego (San Diego Superior Court Case No. 37-2007-00067110-CU-PA-CTL), the City Council voted 8 to 0 to approve the settlement. The motion was made by Councilmember Atkins with a second by Councilmember Faulconer.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of San Diego that the Council authorizes:

- 1. The sum of \$57,500.00 to be paid from the Public Liability Fund (81140) in settlement of each and every claim against the City, its agents and employees, arising from the Litigation.
- 2. The City Auditor and Comptroller to issue a check in the amount of \$57,500.00 payable to Robert Schroth and James Cooper.
