- 4. That the City Auditor is further authorized to transfer the amount of \$6,157,113 from General Services Department 534, Street Division General Fund No. 100, to Fund No. 630221, Contributions from 100 Fund, CIP 59-001.0, Annual Allocation Resurfacing City Streets.
- 5. That the expenditure of an amount not to exceed \$6,181,613 is authorized, solely and exclusively to provide funds for the above contract, contingency, and related costs, to be expended as follows: \$6,157,113 from Fund No. 630221, Contributions from 100 Fund, CIP 59-001.0, Annual Allocation Resurfacing City Streets; \$16,900 from Sewer Revenue Fund No. 41506; and \$7,600 from Water Department Fund No. 41500.

- 6. That the Mayor or his designee is authorized to execute an option to extend the contract for asphalt overlay of additional streets, in an amount not to exceed \$5,887,251 contingent on the availability of additional funding and provided that the City Auditor and Comptroller furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 7. That the City Auditor is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
- 8. That the above activity is categorically exempt from the California Environmental Quality Act pursuant to CEQA Guidelines section 15301(c), as the repair, maintenance, or minor alteration of existing streets, sidewalks, gutters, and similar facilities.
