INTERNET CRIMES AGAINST CHILDREN (ICAC) STATE GRANT

WHEREAS, the California Governor's Office of Emergency Services (OES) has solicited proposals for State Internet Crimes against Children grants; and

WHEREAS, the San Diego Police Department participates in the San Diego Internet Crimes Against Children (ICAC) Task Force; and

WHEREAS, the City of San Diego Police Department wishes to apply for, accept and expend grant funds for the proposed program under this solicitation to support ICAC; and

WHEREAS, the City is seeking \$250,000 in grant funding to be used for personal services, including a word processing operator; operating expenses including travel money for team members to attend specialized training, and computer needs; and an undercover vehicle; NOW THEREFORE.

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor (or his designee) be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to apply for, accept, and expend the grant funds from the State of California, OES.

BE IT FURTHER RESOLVED, that the Council hereby authorizes the Mayor (or his designee) to execute all aspects of program operation, including any amendments, extensions, or renewals, for a period of up to five years, provided funding is made available, and to certify that the City will comply with all applicable statutory or regulatory requirements related to grant funding.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to accept, appropriate and expend these grant funds up to an amount not to exceed \$250,000.

BE IT FURTHER RESOLVED, that any resources received hereunder shall be used to supplement and not to supplant expenditures controlled by this body; and that personnel positions, if any, funded under this grant are not subject to local hiring freezes.

BE IT FURTHER RESOLVED, that this agreement is subject to the City's Equal Opportunity Contracting (San Diego ordinance No. 18173, Section 22.2701 through 22.2702) and Non-Discrimination in Contracting Ordinance (San Diego Municipal Code Sections 22.3501 through 22.3517).
