BE IT FURTHER RESOLVED, that the use of City Forces in Water Fund 41500, CIP 73-083.0 Annual Allocation -Water Main Replacement is authorized solely for the construction of Water Group 541, Sub-CIP 73-855.2 in an amount not to exceed \$400,000.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized upon advice from the administering department, to transfer excess funds, if any, to the appropriate reserves.
