A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO ACCEPT THE CONVEYANCE OF REDEVELOPMENT AGENCY-OWNED PROPERTY AND ALL BRIDGE PROJECT IMPROVEMENTS UPON COMPLETION OF THE PARK BOULEVARD AT HARBOR DRIVE PEDESTRIAN BRIDGE PROJECT.

WHEREAS, the City Council of the City of San Diego implements projects to improve economic and physical conditions in the city of San Diego; and

WHEREAS, the Redevelopment Agency of the City of San Diego, [the "Agency"] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the East Village Redevelopment District Area of the Centre City Redevelopment Project; and

WHEREAS, Agency and City desire to cooperate in the construction and future ownership and maintenance of a pedestrian bridge located at Park Boulevard and Harbor Drive designed to enhance the appearance, functionality, and safety of existing conditions; and

WHEREAS, in order to carry out and implement the Redevelopment Plan, the Agency proposes to pay for or secure other funding for construction of improvements for the Park Boulevard at Harbor Drive Pedestrian Bridge Project in the East Village Redevelopment District; and

WHEREAS, Centre City Development Corporation [the "Corporation"] has reviewed and recommended that the Council of the City of San Diego [the "Council"] accept future conveyance of the Agency-owned property upon which the Pedestrian Bridge will be built, as well as conveyance of all bridge project improvements upon completion of the bridge construction; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Council accepts the future conveyance of Agency-owned property and all bridge project improvements upon project completion, and authorizes the execution of all documents necessary to effectuate such transfer.
