A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SAN DIEGO HOUSING COMMISSION'S AFFORDABLE HOUSING FUND FISCAL YEAR 2009 ANNUAL PLAN.

WHEREAS, on April 16, 1990, the City Council adopted Ordinance No. O-17454 (New Series) establishing the San Diego Housing Trust Fund; and

WHEREAS, on June 3, 2003, the City Council adopted Ordinance No. O-19189 (New Series) establishing the Inclusionary Affordable Housing Regulations; and

WHEREAS, on June 3, 2003, the City Council adopted Ordinance No. O-19190 (New Series) establishing the Affordable Housing Fund to include both the Inclusionary Housing Fund and Housing Trust Fund and revising and amending San Diego Municipal Code [Code] Sections 98.0501 through 98.0518 regarding the San Diego Housing Trust Fund; and

WHEREAS, Code Section 98.0509 requires the Housing Commission to annually hold a series of public hearings to solicit public testimony on programs to be funded by the Affordable Housing Fund, and to prepare and submit an Annual Plan for City Council consideration and approval; and

WHEREAS, the Housing Commission developed the Affordable Housing Fund Fiscal Year 2009 Annual Plan to be submitted for City Council approval; and

WHEREAS, the City Council has considered the Affordable Housing Fund Fiscal Year 2009 Annual Plan and determined that it appropriately addresses the housing needs of lower income residents of the City of San Diego as set out in Code Sections 98.0501 et. seq.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the San Diego

Affordable Housing Fund Fiscal Year 2009 Annual Plan, a copy of which is on file in the office of the City Clerk as Document No. RR-303729, is hereby approved.
