RESOLUTION CALLING A PUBLIC HEARING TO DETERMINE WHETHER THE PUBLIC HEALTH, SAFETY OR GENERAL WELFARE REQUIRES THE FORMATION OF PATRICK HENRY HIGH BLOCK SURCHARGE FUNDED UNDERGROUND UTILITY DISTRICT.

- Lots 559 through 562 & 593 through 619 of Map SAN CARLOS ESTATES UNIT NO. 14, Subdivision Map No. 5684.


