A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING THE FISCAL YEAR 2009 BUDGET REPORTS FOR SPECIFIED BUSINESS IMPROVEMENT DISTRICTS, AND LEVYING ANNUAL ASSESSMENTS.

WHEREAS, the City Council, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.), wishes to continue the promotional activities of specified Business Improvement Districts in the City of San Diego; and

WHEREAS, on MAY 27, 2008, the City Council adopted Resolution No. R- 303786, in which the City Council approved the Fiscal Year 2009 Budget Reports for specified Business Improvement Districts in the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:




