WHEREAS, Eve Selis is a winner of five San Diego Music Awards and received the Jim Croce Award for Excellence and Dedication To Music; and

WHEREAS, Eve Selis, as an independent artist, has sold in excess of 40,000 compact disc recordings; and

WHEREAS, Eve Selis performed for our service men and women on aircraft carriers, in Europe and during the first Gulf War; and

WHEREAS, Eve Selis is known for her compassion for her fellow citizens, making San Diego a better place for all through her philanthropic work - raising more than ten thousand dollars for the City Of Hope, helping to raise eight thousand dollars for United Cerebral Palsy, and by raising money and awareness of domestic violence for the Nicole Brown Charitable Foundation; and

WHEREAS, Eve Selis headlines the annual Everyday Angels Foundation's Project
Warmth, which collects blankets and clothing for the homeless each winter, performs annually
for the Moonlight Cancer Foundation, the Emilio Nares Foundation for children with cancer,
Escondido Eldercare and many other charities; and

WHEREAS, Eve Selis raised donations for victims of the 2003 and 2007 San Diego County Wildfires; and

WHEREAS, Eve Selis is donating all proceeds from her song, 65 Roses, to the Cystic Fibrosis Foundation; and

WHEREAS, Eve Selis, along with others, organized "Music For Mattie," raising more than fifty thousand dollars for breast cancer survivor Mattie Mills, and the Susan G. Komen For The Cure Foundation. "Music For" is now a grassroots project across the country which inspires communities to help breast cancer survivors in need; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the citizens of San Diego, does hereby commend Eve Selis for her dedication and commitment to her profession and the San Diego community at large.
