

RESOLUTION NUMBER R- 303861

DATE OF FINAL PASSAGE JUN 2 4 2008

A RESOLUTION ESTABLISHING AN UNDERGROUND UTILITY DISTRICT FOR RESIDENTIAL PROJECT BLOCK 61 (BAY HO) FINANCED THROUGH THE CITY OF SAN DIEGO UNDERGROUNDING SURCHARGE FUND.

WHEREAS, by Resolution No. R-303776, a public hearing was called for on JUN 17, 2008, at the hour of 2:00 p.m. in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, to determine whether the public health, safety, or general welfare requires the removal of poles, overhead wires, and associated structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within certain areas of the City of San Diego more particularly described as follows [the District]:

- <u>ALLEY</u> south of Idlewild Way and north of Karok Ave. from Idlewild Way to its end at 4621 Jutland Dr.
- MORAGA AVENUE from its intersection with the Alley North of Clairemont Mesa Blvd. to a line +/- 100 feet north of Idlewild Way.
- <u>ALLEY</u> north of Jemez Dr. and south of Clairemont Mesa Blvd. from its intersection with Jutland Dr. east to its intersection with Moraga Ave.

- <u>KAROK AVENUE</u> from its intersection with Idlewild Way to a line +/- 75 feet south of Idlewild Way.
- <u>LA JUNTA AVENUE</u> from its intersection with Idlewild Way to a line +/- 92 feet south of Idlewild Way.
- <u>LUNA AVENUE</u> from a line +/- 85 feet west of Jutland Dr. to a line +/- 20 feet east of Clairemont Mesa Blvd.
- <u>POCAHONTAS AVENUE</u> from its intersection with the Alley north of Clairemont Mesa Blvd. south to its intersection with the Alley north of Jemez Dr.

WHEREAS, Exhibit Attachment DISTRICT 6 BLOCK 61 UNDERGROUND UTILITY DISTRICT (Sheets 1 through 3), Map, and Exhibit Attachment GENERAL BOUNDRY DESCRIPTION FOR THE DISTRICT 6 BLOCK 61 UNDERGROUND UTILITY DISTRICT (Pages 1 through 3), Legal Description, depicts the above District with greater specificity; and

WHEREAS, notice of such hearing has been given by the Mayor to all affected property owners as defined in Chapter VI, Article One, Division Five of the San Diego Municipal Code, and the utilities concerned in the manner and for the time required by law; and

WHEREAS, such hearing has been duly and regularly held and all persons interested have been given an opportunity to be heard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The City Council hereby finds and determines that the public health, safety, or general welfare requires the removal of poles, overhead wires, and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within the areas set forth above and that pursuant to Chapter VI, Article One, Division Five of the San Diego Municipal Code, the above areas are hereby declared to be underground utility districts in the

City of San Diego, and the maps and document referred to above are hereby incorporated as a part of this resolution.

- 2. The Mayor is hereby authorized to establish schedules for the underground conversion of all poles, overhead wires, and associates structures in said District.
- 3. The Mayor is hereby instructed to notify all affected persons as defined in Chapter VI, Article One, Division Five of the San Diego Municipal Code, and all affected utility companies of the adoption of this resolution within fifteen days after date of adoption. The Mayor shall further notify affected persons as defined in Chapter VI, Article One, Division Five of the San Diego Municipal Code of the necessity that if they desire to continue to receive electric, communication, community antenna television or similar or associated service, they shall permit the installation of all necessary facility changes on their premises, or provide such changes at their own expense, so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules, regulations, and tariffs of the respective utility company on file with the Public Utilities Commission of the State of California (as of the date of the adoption of this resolution) and subject to all other applicable requirements of State law and City ordinances. The Mayor's notification shall be in the manner provided in Chapter VI, Article One, Division Five of the San Diego Municipal Code.

BE IT FURTHER RESOLVED, that this activity is categorically exempt from CEQA Guidelines Section 15302(d), and Public Utilities Commission General Order 131-D dated August 11, 1995.

<u>LUNA AVENUE</u> from a line +/- 85 feet west of Jutland Dr. to a line +/- 20 feet east of Clairemont Mesa Blvd.

<u>POCAHONTAS AVENUE</u> from its intersection with the Alley north of Clairemont Mesa Blvd. south to its intersection with the Alley north of Jemez Dr.
