A RESOLUTION OF THE CITY COUNCIL TRANSFERRING FUNDS AND RELATED ACTIONS IN CONNECTION WITH ROAD REPAIRS ON SOLEDAD MOUNTAIN ROAD.

WHEREAS, the City is making repairs to Soledad Mountain Road, which was damaged by a landslide in October 2007, and

WHEREAS, in order to continue repairs while the City's request for state and federal funds is pending, it would be in the City's best interest to transfer funds from other Capital Improvement Program projects, to be repaid after state and federal funds are received; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That in accordance with the Annual Appropriation Ordinance, the City Auditor and Comptroller is authorized to amend the Fiscal Year 2008 Capital Improvement Program budget by increasing CIP 52-805.0, Soledad Mountain Road Emergency Repair, by an amount not to exceed \$2,270,000.

2 That the City Auditor is authorized to transfer the amount of \$2,270,000 to TransNet Fund No. 30300, CIP 52-805.0, Soledad Mountain Road Emergency Repair, from the following accounts:

\$925,000 from CIP 52-679.0, Miramar Road
\$200,000 from CIP 52-676.0, Mira Sorrento Place
\$380,000 from CIP 68-006.0, Guard Rails
\$200,000 from CIP 68-001.0, Cooperative Signal Projects
\$ 50,000 from CIP 58-001.0, New Developments
\$270,000 from CIP 52-716.7, West Point Loma Sidewalk
\$245,000 from CIP 52-719.0, Mission Beach Boardwalk Bulkhead

3. That the expenditure of an amount not to exceed \$2,270,000 from TransNet Fund No. 30300, CIP 52-805.0, Soledad Mountain Road Emergency Repair, is authorized, solely and exclusively to provide funds for repairs to Soledad Mountain Road.

4. That the Mayor or his designee is authorized to reimburse the above CIP project funds with state and federal money when received.

5 That the City Auditor is authorized to re-appropriate funds to the originating sources within TransNet Fund No. 30300 as identified above, or to return excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.

6. That this activity is statutorily exempt from the California Environmental Quality Act pursuant to CEQA Guidelines section 15269(a) because this activity is taken to maintain, repair, restore, demolish, or replace property or facilities damaged or destroyed as the result of a disaster in a disaster stricken area in which a state of emergency has been proclaimed.



A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING SETTLEMENT OF ALL PENDING CLAIMS MT. SOLEDAD MEMORIAL OF THE ASSOCIATION, INC., AGAINST THE CITY AND ASSIGNMENT OF CERTAIN FEDERAL EMINENT DOMAIN PROCEEDS

WHEREAS, the Mt. Soledad Memorial Association, Inc., paid to the City of San Diego

\$106,000 [Purchase Money] for the purchase of the City's Mt. Soledad Memorial property

[Memorial Property], and

WHEREAS, the sale of the Memorial Property was voided by a federal court in the case

of Philip Paulson v City of San Diego, United States District Court Case No. 89cv00820 GT

(POR); and

WHEREAS, the City has not yet refunded the Purchase Money to the Association; and

WHEREAS, the Association has a pending claim against the City for the Purchase

Money, with interest, and the improvements it made on the Memorial Property, totaling

\$1,211,030.57; and

WHEREAS, on August 14, 2006, Congress transferred title to the Memorial Property to the Federal Government by way of an immediate legislative taking, for which the City is entitled to be compensated. *See* the Preservation of Mt. Soledad Veterans Memorial Act, Pub. L. No. 109-272, § 2, 120 Stat. 770 (2006) [Preservation Act]; and

WHEREAS, as a result of settlement discussions between the City Attorney and the Association, the Association has agreed to release all pending claims it has against the City, including without limitation any claim to the Purchase Money, with interest, if the City will assign to the Association all of its interest in the proceeds it is entitled to receive pursuant to the Preservation Act; and

WHEREAS, the Council of the City of San Diego finds it to be on the best interests of The City of San Diego to enter into a settlement agreement with the Association; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Attorney is authorized, on behalf of The City of San Diego [City], to enter into a settlement agreement [Agreement] with the Mt. Soledad Memorial Association, Inc. [Association], whereby the Association releases all claims it may have against the City, including without limitation all monies [Purchase Money] paid by the Association to the City for the purchase of the City's Mt. Soledad Memorial property, including without limitation any claim to interest thereon, in return for the City's assignment to the Association of all federal condemnation proceeds the City is entitled to receive from the United States of America as a result of the Preservation of Mt. Soledad Veterans Memorial Act, Pub. L. No. 109-272, 120 Stat 770 (2006); and BE IT FURTHER EESOLVED, upon execution and delivery of the Agreement, the

Auditor and Comptroller is authorized to release any restrictions on the Purchase Money held by

the City, including without limitation any interest earned thereon.
