RESOLUTION WAIVING COUNCIL POLICY 000-21 REGARDING THE SUBMISSION OF BALLOT PROPOSALS FOR THE NOVEMBER 4, 2008 ELECTION.

WHEREAS, on June 25, 2008, the Committee on Rules, Intergovernmental Relations, and Open Government [Rules Committee] considered ballot proposals from members of the public and independent departments for inclusion on the November 4, 2008 ballot; and

WHEREAS, pursuant to Council Policy 000-21, ballot proposals are docketed for Council consideration 120 days prior to the election, which would be the Council meeting on July 7th, 2008; and

WHEREAS, given the complexity and breadth of the items which may be included on the November ballot, additional time between the Rules Committee and the Council's consideration would be helpful to ensure adequate time to review and analyze the proposals and to address questions raised by Rules Committee members; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council hereby waives Council Policy 000-21 to allow the Council to consider proposed ballot measures for the November 4, 2008 election on July 15, 2008, instead of July 7, 2008.
