WHEREAS, the Grand Jury requested that the San Diego City Council respond to Report findings 1, 2, and 3, and recommendations numbered 08-28, 08-29, 08-30, 08-31, 08-33, 08-34, 08-35, and 08-36; and

WHEREAS, the Office of the Independent Budget Analyst has proposed a response to the Report as set forth in IBA Report No. 08-68 dated June 25, 2008, for the City Council's consideration; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council approves and adopts as its own the response to the to the 2007-2008 San Diego County Grand Jury Report filed April 16, 2008, and titled "San Diego Development Services Department: Professionals in a Maze," as set forth in IBA Report No. 08-68 dated June 25, 2008.

BE IT FURTHER RESOLVED, that the response to recommendation 08-31shall be revised to address the issues and concerns about training raised during the budget process.

BE IT FURTHER RESOLVED, that the Council President is authorized and directed, on behalf of the San Diego City Council, to execute and deliver the above-described response to the Presiding Judge of the San Diego County Superior Court no later than July 15, 2008.
