

RESOLUTION NUMBER R- 303900

DATE OF FINAL PASSAGE JUL 07 2008

MARTINEZ RANCH ROAD NAME CHANGED TO HIXSON
MESA WAY.

WHEREAS, the applicant, Christopher S. McKellar dba Capella Development, the developer of Martinez Ranch Business Park, has requested that Martinez Ranch Road, a 2-lane local street lying between Bristow Court and Britannia Court within the Martinez Ranch Business Park, be named in honor of Robert Hixson, a long-time member of the Otay Mesa business community and currently chair of the Otay Mesa Planning Committee; and

WHEREAS, the Otay Mesa Planning Committee voted 9-0-1 to approve the street name change; and

WHEREAS, the City shall not incur any additional costs associated with the installation of any signs named after Robert Hixson in that all costs associated with the processing of this project are to be recovered from a deposit account maintained by the Capella Development, the applicant; and

WHEREAS, all the known property owners on Martinez Ranch Road have approved that the name of the Road be changed to Hixson Mesa Way in order to provide a street named in honor of Robert Hixson; and

WHEREAS, the street name change is consistent with the Otay Community Plan; and

WHEREAS, Section 34091.1 of the California Government Code authorizes the City Council to change the name of City streets by resolution; and


WHEREAS, under Charter Section 280(a)(2), this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body, a public hearing was required by law implicating due process rights of individuals affected by the decision, and the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That Martinez Ranch Road, more particularly shown on Drawing No. 20611-B, attached hereto as Exhibit "A," is hereby changed to Hixson Mesa Way.
2. That the City Clerk shall cause a certified copy of this resolution, with Exhibit "A," attested by her under seal, to be recorded in the Office of the County Recorder.
3. That the City Clerk shall forward a copy of this resolution to the San Diego County Board of Supervisors pursuant to California Government Code Section 34092.
4. That this action is exempt from the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060(C)(3).


