DATE OF FINAL PASSAGE JUL 15 2008

WHEREAS, Charles McKain was born and raised in San Diego, where he graduated from Hoover High School in 1963, earned a Bachelor of Arts Degree in History from Stanford University in 1967 and earned a Juris Doctorate from the UCLA School of Law in 1974; and

WHEREAS, since 1968, Charles McKain has been a Democratic volunteer, financial contributor and fundraising organizer for local, state, and national candidates; and

WHEREAS, in 1976, Charles McKain became a member of the San Diego Democratic Club, which he is still a member of, and has served as Vice President, Treasurer and Political Action Director; and

WHEREAS, in 1977, Charles McKain became a delegate to the California Democratic Council Conventions and served a total of six years on the Bylaws Committee; and

WHEREAS, in 1978, Charles McKain became a member of the California Democratic State Central Committee, serving as Secretary and member of the Administrative/Bylaws Committee, the Executive Committee and the Annual Awards Dinner Committee; and

WHEREAS, in 1980, Charles McKain was elected to serve as a delegate to the Democratic National Convention and was among the first openly gay delegates from San Diego; he also served as a delegate at the 1992, 1996 and 2000 conventions; and

WHEREAS, from 1989 to 1991, Charles McKain was a member of the Credentials Committee of the California Democratic Party; and

WHEREAS, from 1989 to 1993, Charles McKain was a member of the San Diego County Human Relations Commission, where he served as Vice Chair and Secretary; and

WHEREAS, Charles McKain served as the representative of the San Diego Unitarian Universalist Church to the Life Lobby during the late 1980s and early 1990s; and

WHEREAS, in 1990, Charles McKain served as a spokesperson for the Gay/Lesbian Ad-Hoc Coalition for San Diego City Council Redistricting and, in 2001, he helped to design the 3rd Council District; and


WHEREAS, since 1991, Charles McKain has been a member of the Rules Committee of the California Democratic Party; and

WHEREAS, in 1994, Charles McKain received the Henry Auerbach Award as "San Diego County Democrat of the Year;" NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby commend Charles McKain for the progress he has helped bring to fruition and for the imprint he has had on San Diego's LGBT and Democratic communities.
